### **Equestrian Skills Development level competitions are non EC-sanctioned events administered by Ontario Equestrian with the following conditions:**

- A. OE membership required (owner and rider)
- B. Competitions must be stand alone
- C. Competitions may extend over a maximum of two days from November to April (over one day from May to October) however each division must be completed on one day of the competition
- D. No prize money
- E. Exhibitors do not require a Sport License
- F. No drug fees
- G. Must use OE Accredited Officials or EC recorded officials - to be approved by the OE
- H. Certificate of Insurance
- I. Medic/Emergency personnel must be on site
- J. Maximum level of classes as per OE discipline guidelines
- K. Competition report and officials report form is due within 14 days after the last day of the competition
